

2. Issue 2- New Windows:

Notes from Discussion:

\*Kabin Thomas opened discussion

\*Dean Christensen & Bob Perrin presented issue & proposed plans to address window situation; history of issue: started in April of 2016; difficult time finding contractors to make new windows vs restoring old, so repair has become prominent solution; Proposal- remove most damaged window & use it as "model" for how to repair OR replace remaining windows (temporary replacement will take it's place); make final plans based on this analysis, including developing final cost estimates; casements around window frames is an additional unknown variable that could necessitate additional costs in order to complete job correctly; \$20,500 is current budget but can/will expand based on need; timeline is unknown but it will take place one window at a time since this is the only way a qualified contractor would agree to take the job;

Congregants significant Discussion & Question notes:

Q: is \$20,000 church funds

A: not church funds and thus isn't included in this vote

Q: what will happen when one window is being fixed

A: temporary replacement will be put in place to protect from elements (transparent or translucent)

Q: will standards of original construction be met or exceeded with respect to quality of materials and workmanship

A: Yes

Motion: Authorize the board to spend more than \$15,000 of church funds to begin project on 1 window to be completed before the next congregational meeting, at which point we will have a better idea of how to proceed with the rest of the windows and can vote on additional funds at that time. MINISTER'S ANNUAL REPORT April 2017

We experienced major changes in the 2016-17 church year. We began the year with a single service; greater attendance and greater energy were heartening from the beginning of that experiment. Nonetheless, we found the timing of worship and forum uncomfortable; so we changed the schedule once again, and found the results even better. In the midst of these changes, the nation apparently also felt the need to change, and the election brought us (and other Unitarian Universalist congregations around the country) record attendance. And it's not just attendance that has grown: if I include those who plan to join later in April, almost 30 members will have joined this church year.

The growth is not only in the worship service, but also in Sunday school, where attendance has more than doubled. Participation is also high in service projects (Community Meals, mentoring at Wakonda Elementary School, volunteering at Nathan Hale Middle School) and in classes (the reformatted introductory classes and new Taoism class stand out).

Most impressive is the "Gather Our Spirit, Dream Our Future" workshop that we will have later this month. A large percentage of the congregation has already signed up to clarify the covenant, mission, and direction for our church. What happens at that workshop will set the tone for decades.

A strong church does regular battle with entropy. We always try to improve Sunday worship, and we are moving toward offering the same quality throughout the church year. Ongoing too is the need to refocus on welcoming the newcomer—particularly when the newcomer has political or religious beliefs different from our own. The need to maintain the extraordinary historic structure and the need to play a greater role in our city and state—these aspects too need our ongoing commitment.

It is an honor to be part of this congregation. May our best time be yet to come.

## **Ministry Team Council**

The Ministry Team is composed of the approximately two dozen individual teams that serve the church. The Ministry Team Council (the Council) provides procedures, direction, support and leadership to the individual teams. The membership of the Council is the President-Elect chosen by the congregation, a Board appointed member for a two-year term, and a member elected by the teams for a two-year term. The Board appointee and the Ministry Team appointee alternate terms. The Council meets once a month and the teams meet once every two months. All members are welcome at both meetings. Our newsletter is *The Candle (*formerly known as Voluntary Servitude) which is emailed to all team leaders each month. The Council does a great deal of decision-making around events in the church, administrative details, problem-solving, and support for the teams.

## **President's Report**

Our board has been busy and very engaged in helping us behave like the a big church in preparation for growth in spirit and numbers.

Here is what we have done and what we have started:

- Church-wide leadership retreat led by Cy Wakeman on August 6, 2016.
- Organized congregational meeting and vote on single service.
- Organized congregational vote for permission to begin window replacement in sanctuary.
- Approval of review and revision of board policy on public stands on social issues.
- Approval of fundraising project to purchase Tubach painting to hang in the foyer.
- Approval and planning for all-church workshop to design mission statement, vision statement and covenant, using a UU consultant who is an expert in Appreciative Inquiry to be held in April with the results put to a vote at the Annual Meeting.
- Initiation of process review comments on board meeting.
- Annual review of Rev. Frank's ministry, and health insurance, salary, etc.
- Initiation of review of board by-laws and board policies which will extend into next year.
- Initiation of a board training workshop to be held in June of 2017.
- Review of financial structure of capitol trustees and approval of the trustees setting up an advisory group that will remain constant.
- Initiation of Board Talk Back at Coffee Hour once a month.
- Formulation of guidelines for the MTC to use in discerning meetings, classes and events in our church to respect political diversity, our principles and our mission.
- Review and approval of church budget.

## **Director of Religious Education**

The Religious Education volunteer staff came together last year at this time to cover my duties while I underwent surgery and recovery. I am pleased to be back.

We continue to increase in attendance in all areas. In January and February of 2017, RE attendance was very close to triple 2014 numbers. We had 31 children at the 2014 Easter Carnival and 61 children in 2017. We are pleased with this growth but not complacent. We are always seeking ways to encourage attendance and participation.

One example of this is our POPs program which provides fellowship for our parents of preschoolers. This has become a vibrant group. We have the privilege of offering consistent professional childcare to parents of young children. Their participation has been up as a result.

The children's vegetable garden is another important program. Jody Petrow, our passionate gardener, has already planted some of the children's plants which they grew from seeds. We look forward to a bountiful harvest of involvement and vegetables.

The Our Whole Lives comprehensive sexuality program has presented a K-1 class and a very inclusive 7-8 class. We are proud to support these programs even as other church and school-based programs decrease.

Last summer, we welcomed two new YRUU youth advisors, Adam Sagert and Carolyn Miller. A combined program from the two UU churches, parents from both congregations developed a new description of best practices for the group.

Youth in Sunday School have spent the year creating their own board game based around making ethical choices. Ryan and Bethany Cook and Geoff Chenoweth have been faithful leaders in this pursuit. Grades K-5 students have studied the world religions and also the issues of critical thinking.

We look forward to a robust involvement in our Harry Potter curriculum this summer, as well as our yearly summer camp, also based on Harry Potter.

## Twenty Years Ago — 1996-1997

From the Annual Report for '96-'97:

President Kim Dunovan reported that the past church year, under the Interim Ministry of Angeline Theisen, had made considerable strides in pursuit of two goals. The first was a re-assessment of "who we are." A survey revealed we were more diverse in terms of religious beliefs than first thought. Prairie Star executive Nancy Heege facilitated a workshop to analyze our "self study." The second goal was to instill a greater sense of community in the church.

John Hruska, chair of the Ministerial Search Committee, reported that three candidates for the settled minister position were interviewed and sermons by each were heard in nearby UU churches. However, the committee found that none were "good fits" for our church. So another interim minister would be sought while the search for a settled minister would continue.

Several innovations began during the year which included:

1. Children took part in the service. Under the leadership of Cheryll Wallace the service included the "Story for All Ages" and the singing of "Go Now in Peace" as the youngsters departed for Sunday School.

2. Summer services were to begin in the summer of '97 for the first time.

3. The House and Grounds Committee chaired by Nancy Scott took on the task of rearranging and refurbishing the Minister's Office.

During the year the church welcomed 26 new members bringing our total membership to 271.

When TAG returned to meet in the fall, the steering team felt that the group should be more relevant to the times; the result was a restructured group that resembles a more program-driven entity. With restructuring, came the name change to AHA! (Atheists, Humanist, Agnostics). After the election, the group realized that the world is changing ever faster and proposed a way to explore these changes and how they affect our lives as atheists, humanists and agnostics through a series entitled *Trumpism vs. Humanism*.

The Black Lives Matter Team was started soon after our church committed to standing in solidarity with Black Lives. Hanging a banner outside is nice, but we wanted to further our commitment with action. As a group, we seek to bring in education, information and lift up the voices of those in our community who are marginalized. We are still finding our way and grapple with how to have fully nuanced conversations on race in a predominantly white space.

We are still a relatively new group so we have not had a lot of activities, but we have sponsored a forum that was facilitated by local BLM activist Morgann Freeman; hosted a showing of the documentary *The 13th* and have also had a card sales campaign with lovely Beyoncé art cards. The proceeds went to benefit the new Mind & Soul radio station that broadcasts from the Malcom X Foundation. We also facilitated a book circle for the book *Waking Up White*. The attendance at meetings has not reflected all who belong to the Facebook group and who have expressed interest. I hope going forward we can see more growth and involvement from the congregation.

The Capital Trust was established in 1981 to provide management of the Church's long-term capital investments and keep them independent of the daily operations of the Church. The Trustees of the Capital Trust (who serve staggered three-year terms) during the past year were Evelyn Whitehill (May 2018), Dean Christensen (May 2019) and Steve Hutchinson (May 2017).

Investment income is distributed monthly to the Church for operating expenses. Preservation and growth of the principal is the primary directive and principal cannot be distributed to the Church without a vote of the congregation. The Trust also handles the investments of two small restricted use donations: Music and Women's Alliance. There is some question about whether the Women's Alliance fund is a restricted fund of the Church or whether it belongs to the Church and is segregated by the Board for use at the recommendation of the Women's Alliance. That matter is to be resolved by the Board.

Approximately 71% of the Trust's total assets are invested in two Vanguard equity funds. The balance of the investments are invested in Fidelity and T. Rowe Price current income funds—15% in mortgage funds and 14% in bond funds. The Trust no longer holds any cash.

In the Fiscal Year ended April 30, 2016, the Trust distributed \$14,323 of income to the Church (compared to \$13,650 last year). Of that total amount, \$13,517 was attributable to regular trust income and \$806 to restricted use income. During the year, the market value of the investments managed by the Capital Trust Committee increased from \$484,435.02 (at April 30, 2016) to \$527,004. During the last fiscal year, the Capital Trust Fund produced a net gain of 11.8% that consisted of a yield of 3.0% that was distributed to the operating budget of the Church coupled with an increase in the market value of the investments of 8.8%. This performance tracked closely with broad stock market indices.

The Caring Team also reaches out to our members who, for health reasons, rarely attend church. Terri Lynn Brewer has helped with this effort by getting occasional and seasonal cards for members of the congregation to sign after services. Special thanks for her help!

The Caring Team participated in the Teams Fair this year but had no regular meetings this year. Most communication is via e-mail and most members follow the church Facebook page. We would also like to recognize the Hope in Action sub-team, who work on special projects.

## Sub-Team of Caring: Hope in Action

Hope In Action was launched in August 2014 as a new sub-team of the Caring Team. The purpose of Hope In Action is to make it easier for First Unitarian Church of Omaha members, friends, regular attendees and their spouses to ask for support. Hope In Action is available when people are dealing with a medical problem, need transportation or help around the house, can use assistance with referrals to social service agencies or just need someone to talk to about the ups and downs of life. Short-term emergency financial assistance may be available for lodging, food, clothing, medication, transportation and utilities.

Hope in Action uses a team approach, so at least three members of Hope in Action must participate in determining the nature of the response to a request for assistance.

Requests for assistance must be made directly by the person needing help. Hope in Action does not respond to any anonymous or third party requests for assistance. A confidential request for assistance from Hope In Action may be made by (1) sending an email to the designated email address or (2) using the Hope In Action link on the church website. Hope In Action has developed an Omaha Resource Guide for social service referrals that is provided to folks who contact Hope In Action and people who come to the church door seeking assistance.

Hope In Action provided the following support during the past year:

• Provided emotional support, financial counseling and emergency financial assistance to a church family who was a victim of fraud, resulting in the loss of all of their savings.

With the retirement of Bob McMeen in 2016, First Unitarian was seeking new choral leadership. William Miller accepted the position of Choir Director in September 2016. William solicited applications and interviewed potential choral accompanists. Elizabeth Kelly was selected, accepted the offer and began on the same night at the first rehearsal of the year, September 14. Rehearsals are held each Wednesday from 7:00pm to approximately 8:30pm.

## **Community Meals**

First Unitarian has a very committed group of regular volunteers who regularly staff the dining room at First Baptist Church. They set up, clean up, and visit with our guests. This year the group has included Kay Lynn Goldner, Louise Jeffrey, Dean Christensen, Linda Hess, Terri Lynn Brewer and numerous support persons.

Over the course of the year, with the help of other First Unitarian volunteers, we served six meals. An online sign up and some paper sign up sheets were both offered to those interested in participating beginning three to four weeks before each meal. Opportunities were also pointed out in *The Flame* and in orders of service. While we partially fund the meals through Share the Plate donations, many people generously donated the food they prepared. Cooking is often done by volunteers who signed up to prepare 10-16 person servings of a given recipe or put their own twist on the main dish as in the case of our beef chili meal. Other generous donors completed the meals by making delicious, easy to serve desserts and side dishes. Contributions were dropped off at First Baptist the morning of the meal, or left at our church to be picked up by participants the morning of the meal. The meals included a Chicken Tetrazinni, pizza from Little Caesar's, beef and chicken enchiladas, chili and deli-fried chicken from HyVee.

Upon each occasion, an enthusiastic crew of First Unitarian volunteers met at First Baptist to finish preparing food, visit with guests, serve and clean up. The meal begins with a blessing, usually given by Rev. Frank or one of the key members, and it is a rewarding time of camaraderie with friends, and a chance to be of service to our community.

## **Covenant of Unitarian Universalist Pagans: Mystic Sojourn (CUUPS)**

The goals of Covenant of Unitarian Universalist Pagans (CUUPS) include educating people about paganism and promoting interfaith dialogue, along with encouraging the greater use of poetry, dancing, and creative rituals in UU worship. We collectively organized and led two services in March and November, and one in March 2017. As a group, we are growing and working toward a more collective planning and leading of rituals with all participants. We are also implementing an alternating yearly group co-leadership with more participants. Kathy Alexander is currently being phased in while Kate Godfrey is being phased out this year.

We try to hold our public meetings in the church Common Room. Our primary goal is to gather for public rituals celebrating the 8 quarter and cross quarter holidays during the wheel of the year. We are currently trying to pair up novices with more experienced leaders for developing rituals. We also have a goal of building up an archive at First UU of rituals for our group. We held a retreat for the second year in September 2016 at Platte River State Park. We started a monthly book study group at First Unitarian in 2016, running through 2017. We are studying together and working our way through basic pagan literature which teaches the art of rituals. The Action Teams keep OTOC members informed about the bills and encouraged them to contact their individual senator.

The Finance Team has responsibility for advising the Board, the Ministry Team and the Treasurer on the financial functions of the church and assists the senior staff in carrying out specific functions. Walt Jesteadt continued to serve as Treasurer as well as finance chair. Work completed under both headings will be summarized here, but finances for the year and a proposed budget for the 2017-2018 year will be presented in a separate report. The Sarah Joslyn Society and Fundraising are also covered in separate reports.

During the past year, Bill Ross continued to perform many church accounting functions including the payroll. Catharine Dixon continued handling most of the data entry plus some accounting functions. Clyde Kramer handled disbursements. Walt Jesteadt handled contribution statements, monthly reports to the Board and automatic pledge payments through Vanco, a company that specializes in scheduled ACH transfers.

We had been using Vanco in recent years to handle twice monthly direct payroll deposits for our staff. Vanco stopped providing that service and we made arrangements with Premier Bank to make the transfers directly from our main checking account. We have the option of creating similar batch transfers for people wishing to make automatic pledge payments, replacing Vanco with our own service. Because Vanco charges us a percentage, we could save approximately \$600 per year and will look at implementing the system during the next year.

Contribution Statements were mailed in August, October, January and April. The January mailing for tax purposes is required by law. The April mailing provided information on the status of pledges before the end of the current church year as well as information on new pledges. We continued to email contribution statements to 75 households that gave us permission to do so. The Preserve Our Building Fund campaign was again held in January/February, with the help of Jaime Alexander and Louise Jeffrey. The fund total increased from \$58,758 in February 2016 to \$63,799 in February 2017.

The members who pay their pledges by monthly automatic deposits handled by Vanco increased from 38 to 44 during the year. All Vanco contributors were contacted during the stewardship campaign to ensure that Vanco transfers in May would be consistent with new pledges. Our Excel summary of Vanco participants was updated.

Last year's report described a plan to invest \$200,000 from our cash reserves by creating an account as part of the UUA Common Endowment Fund. Concerns with the low rate of return from the fund caused us not to make the investment, while a \$302,000 bequest from Dick Holland further increased our cash reserves. The Finance Team met to discuss the issue in February 2017 and could not reach a consensus. At the March 2017 Board meeting, it was agreed that Dean Christensen, a new Trustee of the Capital Trust, would consult with other trustees and other knowledgeable members of the church and would begin investing money in exchange traded funds through the church's TD Ameritrade account. Walt Jesteadt will enter the actual transactions and will move the necessary funds from our checking account to TD Ameritrade.

Clyde Kramer continued coming to the church office once a week to handle disbursements. This reduces Catharine Dixon's workload and separates our bank deposit function from our disbursement function.

### **FUNdraising Team** Leader: Donna Neff Team Members: Kathi Oliver, Walt Jesteadt and over 50 auction volunteers

Each year's operating budget specifies an amount to be raised by our Team, and this year the goal was \$17,000, holding last year's level. We successfully reached that goal, contributing \$17,000 to the budget as of the end of February.

The majority of these funds (over \$14,500 profit) came from our annual Halloween Heart & Hand Auction Party, so-named because it sells "seats" to fun social activities and people's skills and services as well as great physical items. Held Friday, October 28, 2016, over 100 people enjoyed a "fall favorites" potluck, costume contest, raffle, door prizes, and both silent and live auctions of 178 items. Kabin and Mary Thomas entertained us as MCs, and free childcare was provided for 22 younger children, who had their own Halloween activities. Brenda Everson-Weisman won the raffle basket, and costume winners were Kabin and Mary Thomas (Disco Duo-1<sup>st</sup>), Jack Perry (Aging Rock Star-2<sup>nd</sup>) and Bruce and Kate Godfrey (The Costume Box-3<sup>rd</sup>). Post-auction billing again worked well, albeit helping spread auction tasks year round.

Other additional sources of fundraising income this past year were \$763 from shopping on Amazon Smile, \$273 profit from the Chili Cook-Off, and \$68 from use of Baker's cards. This year was our first participation in Omaha Gives! on May 25, 2016, an on-line fundraiser for local non-profits. Of the \$5,420 total donated (several pledges were paid that way), \$601 was raised for our featured program of Neighborhood Ministry. This program receives no allocated funds and was selected by vote of the Ministry Team for appeal to both non-church and church members.

Finally, a special thanks to Fellowship Team members, who generously work as partners with Fundraising for the Auction and the Chili Cook-off...and to the many generous donors, buyers and volunteers who make our annual Auction such a success.

## **Holland Lecture Series Committee**

The Lecture Committee sponsors two lectures per year, one in the spring and one in the fall. To date, 24 lectures have been sponsored.

On May 11, 2016, Dr. Naomi Oreskes presented a lecture titled "The American Denial of Climate Warning." Dr. Oreskes is Professor of the History of Science and Affiliated Professor of Earth and Planetary Sciences at Harvard University. Previously she was an administrator and faculty member at The University of California, San Diego. She is the author of *Merchants of Doubt: How a Handful of Scientists Obscured the Truth on Issues from Tobacco Smoke to Global Warming* and *The Collapse of Western Civilization: A View from the Future.* 

On October 26, 2016, Dr. Joseph Carens presented a lecture titled "The Ethics of Immigration." Dr. Carens is a Professor of Policitcal Science at the University of Toronto. He is the author of *The Ethics of Immigration*, and *Immigrants and the Right to Stay*.

On May 10, 2017, Dr. Jacob Hacker will present the final Holland Lecture titled "How the War on Government Let Us to Forget What Made America Prosper." Dr. Hacker was a previous speaker in the lecture series. He is the Director of the Institution for Social and Policy Studies and the Resor Professor of Political Science at Yale University. His books include *Winner Take All Politics*, *The Great Risk Shift* and *American Amnesia*.

The originator and funder of the Lecture Series, and the thought leader of the committee, Dick Holland, died last year. Dick's objective in creating the lecture series was to bring prominent speakers to Omaha and to provide them with a forum for presenting new and enlightening ideas, and he succeeded in doing just that. He graciously invited First Unitarian to sponsor the series at no cost to us. The committee will disband following the Hacker lecture after having sponsored 25 lectures over 12 years. Those of us who served on the committee were privileged to have worked with Dick, and Shelton, who was the committee chairman during its early years.

## **Hospitality Teams**

The Hospitality Teams concept began in 2014 as a new way to approach the Sunday morning tasks we are all familiar with. The goal is to provide opportunities for each church member to help serve the congregation and support the church service; to belong to a team that works together on a regular basis and takes a turn in its leadership; to learn the work that is required to bring our service together, share the knowledge with other team members, and help improve the process; and to become an integral part of welcoming all newcomers to our church. New church members who are physically able and available on Sunday mornings are asked to serve on a Hospitality Team.

It takes about 108 volunteers (nine teams of approximately twelve people each) to make Hospitality Teams work. The teams are purposely large so that team members who are unavailable on the Sunday that their team is scheduled, can be absent without disrupting the smooth flow of the team's work. Currently, the average team has eight members but more are needed. Each team serves six times per year — once every two months.

Four teams serve one Sunday during each of the odd numbered months (September, November, etc.) and four other teams serve one Sunday during each of the even numbered months (October, December, etc.). A fifth team serves each time that there is a fifth Sunday in a month (generally 4 times per year). Team Coordinator Carolyn McNamara is the conduit between the individuals and teams that create our Sunday service and the Hospitality Teams that serve on any given Sunday.

Serving on a Hospitality Team takes about one hour and it only happens six times per year. Some people come in early to set up and some people stay a bit late for clean-up. Because everyone works together, nobody has to spend lots of extra time. Tasks include greeting congregants and visitors when they enter the church; taking up the offering; answering questions and giving directions; visiting with newcomers and helping them feel at home; and tidying up after the service. All of the tasks are documented and introductory training is offered. Team members are encouraged to rotate through the tasks to become familiar with every job.

Hospitality Team Leaders mainly do team coordination. Team Leaders receive information about what is planned for the service from the Hospitality Team Coordinator and share it with their team members. The Team Leader checks to see who will be able to attend on Sunday and schedules who will perform each of the various roles. The tasks are rotated until everyone has a chance to become familiar with each one.

Serving on a Hospitality Team is rewarding and fun and we hope you will volunteer for one and join us!

- •Created "Pathways" class (based on model from First Unitarian Church of Des Moines) to give visitors/ attendees a formal option to become Unitarian Universalists, to promote friendships among attendees, and to teach attendees about the church. Classes were planned, advertised, and facilitated by Carrie with help from Membership Team members and other church leaders.
- •Facilitated new members joining Hospitality Teams through formal process integrated into Pathways curriculum.
- •Planned and held two New Member Celebrations (August 2016, December 2016).
- •Welcomed 12 new members to the church in December following the first Pathways class. Seven new members are now pending following spring 2017 Pathways class.
- •Composed and distributed electronic survey to fall and spring Pathways participants to get feedback about the new class.
- •Restructured "UU & You" class to organize monthly "First Steps" classes to work better with new Pathways schedule/syllabus. Jaime Alexander stepped down from the position of UU & You coordinator.
- •Reviewed and updated the church's list of current, active members.
- •Replaced weekly attendance at Sunday services with a headcount to lighten the workload for team members and to respect the privacy of church attendees.
- •Carrie, Carolyn, and Caitlin represented the Membership Team at the church leadership retreat (August 2016).
- •Recruited new Membership Team members at church-wide activity fair (November 2016).
- Staffed Welcome/Visitors Table every Sunday with volunteers from the team during coffee hour to approach visitors and answer membership-related questions.
- •Updated Welcome/Visitors Table with current issues of The Flame, pamphlets, pictures of new members, and information about church activities.
- •Set up a bulletin board in the Common Room with an envelope for member feedback about church programs they would like to see.
- •Consolidated all Membership Team documents on a Google Drive associated with the portable account: mtchair.firstuuomaha@gmail.com. All documents are available to all team members at all times, and ownership of documents can be easily transferred to the next team chair.
- Initiated the process to update the Membership Team section of the church website so it will be easier to navigate for both visitors and members.

Blessing Bag Day was a success again. Thank you. At least 100 blessing bags were made, and will be used to hand out to those in need who come to our church. The bags contain various personal care items, socks, gloves, and a hat.

Over 75 boxes lunches were made and handed out. The boxed lunch contained two sandwiches, chips, a snack, utensils, and a sports drink.

Assistance in the form of restaurant gift cards were given out, totaling \$400.

Assistance in the form of providing payment for various services was made, totaling \$625.

This important work continues to fill a vital need, and helps close a gap in services to those in our neighborhood.

### The goals in 2016/2017 were to:

• To raise \$1,320 each year for the Unitarian church and village in Firtosmartonos, Transylvania, Romania. This money is used by the village minister, Rev. Katalin Szasz-Cserey, to help maintain the 110-year-old village church and to help with various church/village activities such as the Sunday school and the women's needlework group.

• To raise \$2,400 to provide scholarships to some of the village youth who are either attending high school or college. In 2016/17, this money was distributed to 10 village young people. Since there is no high school close to the village, the youth must board in the cities in which the high schools are located. We received completed questionnaires from all of the scholarship recipients which asked what courses they were taking, what their academic and career goals are, and what the scholarship money was used for. Two of the scholarship recipients have been attending professional schools—one in medicine and the other in law. The Women's Alliance provides \$400 of the \$2,400 that is sent to provide scholarships.

• To provide information to the members and friends of First Unitarian Church about our partner church and village and Transylvanian Unitarianism.

• To recruit members and friends of First Unitarian Church to travel to Transylvania and our partner village.

### Activities:

During July, 2016, Nancy Scott, Kandelyn Scott, and Janet West went on a pilgrimage to Transylvania, Romania. They flew into Kolazsvar (Cluj) Transylvania. While in Kolazvsar, they visited the headquarters of the Unitarian Church of Transylvania and Hungary and attended a church service at the Unitarian church of Kolazsvar. After visiting Torda, Deva, and many other historic Unitarian sites, they spent five days visiting our Unitarian cousins in Firtosmartonos. While there, they participated in the celebration of the 110th year anniversary of our Partner Church village with the residents of the village.

The Partner Church Fund was designated as the Share-the-Plate recipient organization in December 2016.

Rev. Katalin Szasz-Cserey visited Omaha, February 19-23, 2017, after she attended the International Women's Convocation in Monterey, CA. While Rev. Katalin was in Omaha, she visited with Rev. Frank Rivas, Jan Wilson, Jackie Anderegg, and members of the Partner Church Team. The Partner Church Team organized an all-church potluck where Rev. ### **Sunday Services Live Video Streaming and Archives**

Submitted by Bill Ross

In 2015, First Unitarian identified video streaming competence as a potential requirement for successful churches in the future. The most obvious use for video streaming is to broadcast our Sunday services over the internet to members or others who can't be physically present with us in the sanctuary. The church decided to invest in a project to determine if we could develop the necessary competence.

Troy Jensen did most of the work through 2016 and produced an excellent working prototype. Beginning in late 2016, Troy began transitioning out of the project and training several people to take over. We soon learned that Troy has a skillset that is hard to replace and we actually lost ground as we worked through the learning curve. We're getting better now and are making progress on some of the key issues:

- Finding volunteers or others who can be trained to operate the equipment.
- Integrating the video process into the normal flow of the Sunday service.
- Streaming and archiving the resulting video for consumption on-site and remotely.

As attendance at the Sunday services has increased and we have returned to the single service format, we are planning on the video process to cope with potential overflow audiences.

The Office Team and the Worship Arts Team have invested their time into preparing the weekly materials that are needed for the streaming and also to helping prepare us for what will be in the service. The House and Grounds Team has provided significant cabling to tie our equipment into the church's sound and network systems. Kabin Thomas, Bob Hess, Christina Noriega, and Bill Ross have worked on the team with Troy this year. If you have an interest in this project, please contact the church office.

Assuming that we can continue to improve and achieve competence in streaming technology it will enable us to support future opportunities like satellite locations, interactive remote RE programs, and other services to interested participants who can't be physically present in the church.

### **Group Summary:**

Young Religious Unitarian Universalists (YRUU) is for youth in grades 7-12 and is a joint youth group between First and Second Unitarian Churches of Omaha. They meet on Wednesday nights at First Unitarian Church. The YRUU year runs in conjunction with the school year (September – May).

The goals of YRUU are to:

- · Grow life-long Unitarian Universalists
- · Provide worship, celebration and rites of passage for UU youth
- · Learn about the traditions and heritage of Unitarian Universalism
- · Develop personal growth, relationship building & leadership skills for youth

• Help youth to develop a social conscience and learn to be agents of change, as a group and individually, in the world

- · Develop continuity and foster communication between age levels of youth within the program
- · Foster tolerance, understanding and acceptance of diversity.

Youth Adult Committee: One focus of YRUU is a youth-leading structure within the group. The Youth Adult Committee (YAC) is comprised of all youth interested in taking leadership roles, youth advisors, and interested parents. The YAC utilizes the feedback gained from the full representation of youth and parents to plan and organize programming. The YAC meets about once monthly in order to ensure effective leadership for the YRUU, to plan weekly programming, events, and activities. In the past the YAC has had officers but this year the youth chose to forego officer positions and instead focus on all members of the group working together to plan and execute our programming and events.

2016 – 2017 YRUU Activity Summary: We learned and had some amazing discussions this year about important topics. This year saw a change in the leadership of YRUU with new coordinators stepping up after a long run by the previous leadership. We concentrated on building a community among the youth who attended while exploring our beliefs and growing as young members of the church.

Other YRUU activities included:

- \* We developed a new Covenant which all youth signed to demonstrate their commitment.
- \* Fundraiser Brunch
- \* We had an overnight
- \* Ami (Al Fatihah) Amini's presentation on her native home of Indonesia
- \* Bystander Training with Rev. Cyndi Simpson
- \* Debate night where youth discussed current topics,
- \* Game nights
- \* "Step Across" activity nights

\* Worship service at two congregations -- inspired by the theme of Community and reflecting favorite activities from YRUU such as step-across, music worship, and check-in

\* New Year's burning jar ceremony where we "let go" of the past year

\* Halloween bonfire

\* Future events for this school year include bake sale fundraiser and Box City

\* Multiple music worships with youth-selected songs on various themes and a discussion about why the music they selected was meaningful to them

\* Trust-building and leadership exercises led by parent Justin Short

\* Viewing of Documentary "The Sharps' War"

\* A panel discussion on sexual orientation and gender identity with guest panelists from First and Second U as well as the larger Omaha metro area

\* This year's YRUU activities ended with a potluck at First Unitarian (a celebration and honoring of one another and time spent together over the year), as well as a youth service for the entire congregation, which is youth-led and focused (on Mother's Day weekend).

# Other Programs typically facilitated by YRUU (the facilitation of these programs may change as the Transition Team looks at the future of where these programs fit inside of the RE structure and Omaha UU community):

 $\cdot$  Our Whole Lives (OWL): The OWL program helps participants make informed and responsible decisions about their sexual health and behavior. It equips participants with accurate, age-appropriate information in six subject areas: human development, relationships, personal skills, sexual behavior, sexual health, and society and culture. Grounded in a holistic view of sexuality, OWL not only provides facts about anatomy and human development, but also helps participants clarify their values, build interpersonal skills, and understand the spiritual, emotional, and social aspects of sexuality. Our current OWL program is a 26 week/lesson cycle, and the current curriculum, as well as advisor training, is tailored for youth 7<sup>th</sup> grade and older. Parent preview and consent is required prior to participation.

### Comments on the 2016/2017 Treasurer's Report and 2017/2018 Proposed Budget

### **Recent History**

This year marked our sixth year in a row with an end-of-year surplus. This year was unique in that we were above budget in income as well as below budget in expenses. When necessary, we have proposed that a portion of the end-of-year surplus be carried over to be used as income for the next year. We have done that this year to make up for a stewardship campaign total that was below our goal and a goal that was an under estimate of our real needs.

### Results for 2016-17

On May 10, 2016, the official end of last year's stewardship campaign, we had 139 pledges totaling \$260,281. We budgeted \$260,000 in pledge contributions for the year that ended on April 30, 2017 and received \$258,592, with some contributions still coming in. Non-pledge contributions and most other income categories were above budget. We were below budget in expenses, in part because we used non-budget funds for many one-time projects, including \$3,791 in Holland contribution funds to support the new Membership Coordinator position. Other one-time projects included lighting for the parking lot, the workshop to develop new mission and vision statements, and costs related to streaming services. The net result is that we finished the year with a surplus of \$10,886. We received bequests this year totaling \$312,370, bringing total bequests over a two-year period to almost \$500,000. We agreed to use \$140,000 of the bequest from Richard Holland over a 7-year period to provide continued pledges that decrease by \$5,000 per year to reduce the sudden impact of loss of the largest pledge in our annual stewardship campaigns. We are in the process of investing \$300,000 of the recent bequest money with advice from trustees of the Capital Trust.

#### **Stewardship Campaign**

The goal for the stewardship campaign this spring was \$266,000, an increase of only \$6,000 over last year. With the \$5,000 reduction in the Holland pledge, however, this goal required an increase of \$11,000 from other members and friends. As of May 10, 2017, we had 131 pledges for the new church year totaling \$246,557. The low number was surprising, given the success of the previous campaign and the high level of contributions over the past year. The number of pledges is also lower, even though membership is up. We have revised the budget for next year to reflect lower total income from pledge contributions than we had this year.

#### **Proposed Budget**

The proposed budget assumes pledge contributions of \$250,000 for the coming year and use of the full \$10,886 from the 2016-2017 surplus as additional income to balance the budget. The budget also assumes that our investment income will more than double as a result of investing money from recent bequests and revising the rules governing the Capital Trust. Income from the Trust has been limited to interest and dividends whereas almost all foundations now assume income as a percentage of total value. Expenses are 4% higher than those in the current budget, primarily because of a 3% increase in salaries for most staff members, somewhat larger increases granted this year or next year to Catharine Dixon and Frank Rivas and the increased cost of medical insurance. The budget assumes that the Membership Coordinator will continue to be supported from a non-budget growth account.


