### First Unitarian Church of Omaha Minutes of 146<sup>th</sup> Congregational Meeting May 17, 2015

**Quorum:** 176 Eligible Voters

78 Eligible Voters Present

Call to Order: President Louise Jeffrey called the meeting to order at 12:25 p.m.

**Quorum:** Sheri Conner, Secretary, confirmed the presence of a quorum of eligible voting members of the church.

Parliamentarian: Louise Jeffrey recognized Dave Richardson as Parliamentarian.

**Approval of Minutes:** Laurie Gift made the motion to approve the minutes from the 145<sup>th</sup> Congregational Meeting on May 18, 2014. The motion was seconded by Eddith Buis. The motion passed unanimously.

#### Annual Reports:

Minister: delivered by Frank Rivas and printed in meeting book. Ministry Team Council: printed in meeting book. Presidents Report: delivered by Louise Jeffrey and printed in meeting book. Director of Religious Education: printed in meeting book. Trustees of Capital Trust Fund: printed in meeting book. Team Reports: printed in meeting book.

**Proposal for Membership Coordinator:** delivered by Jackie Anderegg, Membership Chair The rationale behind creating a Membership Coordinator position as well as elements of the position and means of funding were discussed. Funding for the first year will be from the Holland development monies. Subsequent years will likely be from the budget.

#### Proposal for Amendment to Bylaws: Louise Jeffrey

The proposed amendment to section 2.F of the Bylaws would be as follows [the proposed amendment would add the phrase which is in bold italics]:

"2.F. Twenty (20%) percent of members eligible to vote shall constitute a quorum for the transaction of business at a membership meeting, and the power to vote shall be limited to voting members present *(including members present via two-way audio-visual communication pursuant to procedures established by the Board*). The Board Secretary shall prepare and make available a list of eligible members not less than (5) business days before the meeting."

The motion for the amendment to the Bylaws was made by Bill Ross and seconded by Kate Godfrey. The motion carried with 73 votes.

#### Presentation of Proposed Budget Adoption of 2015-16 Budget:

delivered by Bill Ross for Walt Jesteadt, Treasurer

The proposed budget assumes pledge contributions of \$245,000 for the coming year and use of \$5,000 from the 2014-2015 surplus as additional income to balance the budget. If our expenses continue to be somewhat lower than projected, we may not need those funds. The biggest uncertainty in the budgeted income for the year is not pledge contributions, but the rental of most of our parking on weekdays to the National Indemnity Insurance Company. If they move during the coming year, we will lose \$735 a month in income.

The proposed budget meets our obligations to the UUA and the Mid America Region and provides a modest raise and appropriate benefits for our staff, while fully funding our programs for the coming year. We continue to have cash reserves that could be used to cover a budget shortfall or one-time expenses outside the scope of the operating budget. Our cash reserves would be sufficient to operate the church for a full year without any income and we can absorb the loss of the parking lot rental income if necessary. Motion to approve the 2015-16 Budget made by John Goldner and seconded by Carolyn McNamara. The

motion passed unanimously.

### Minister's Report to the Congregation — 2015/2016

We continue to grow as a church community, particularly in response to the needs of the world around us. Our commitment to being the lead church in Community Meals expanded this year to also serving a monthly meal at Youth Emergency Services. Our commitment, in concert with Clair Memorial United Methodist Church, to addressing racism in our city grew to the congregation's decision to display a Black Lives Matter banner in front of our church. This second commitment did not happen easily, but it happened well. We listened, really listened to one another first on Facebook, then in an all-church forum. We heard and respected several perspectives; we voted to display the banner; and we continue to accept and recognize differences. An issue that could have divided us became an issue that has made our community stronger.

Our church is in a powerful position. We meet in a beautiful space in a central location; we have two separate music programs, each extraordinary; our Sunday school program, long of high value, is finally attracting more young families; our Sunday attendance, which spans generations, is enviable. We like one another, enjoy church events, and are comfortable with differences in age, theology, and sexual orientation. Most recently, there has been a strong commitment to learning more about our Unitarian and Universalist heritage. When I tell colleagues about this church, they wait for the other shoe to drop. Perhaps you experience the same when you talk with members of other congregations. There is no other shoe.

Let's enjoy this moment and work together to improve on it. At the last meeting of the Board of Trustees, we began talking about moving beyond planning for the next year or two toward envisioning First Unitarian in 10 or 15 or 20 years. We have great potential. We can become a more powerful influence in our community. May we use our potential well.

### **Ministry Team Council**

The Ministry Team is composed of the approximately 24 individual teams that serve the church. The Ministry Team Council (the Council) provides procedures, direction, support and leadership to the individual teams. ### **Director of Religious Education**

The summer of 2015 began with a summer camp which lasted five days at the beginning of June for students aged 5-10. We experimented with many different art forms in the morning and went to field trips related to art in the afternoon. Many volunteers taught games, music, art, and dancing. Parents provided transportation to the various field trips, which included the Union for Contemporary Arts, Connect Gallery, and The Kaneko. A gallery of the artwork was presented to the parents on the last day, and to the congregation on Sunday.

Prior to the fall session, families attended an overnight retreat at the Swanson Center. I created children's art workshops and read stories highlighting themes of appreciation of the natural world.

Fall curriculum was structured around the Birth to 18 guide prepared by the Curriculum Committee of the RE Council. This work will be ongoing. The aim is to provide consistent goals for the teaching of important aspects of UU learning on a three-year rotation. The subject of this year's study is our UU Heritage. The spring classes will focus on particular UU s and end with a history of our own congregation, including images and stories by our resident archivist, Dave Richardson.

A new family social event was begun to bring the parents of toddlers together for fun and pizza. This group, called POPS, gets together on the second Friday of the month. Our nursery professional, Jenny Hastings, and her staff care for children in the nursery. We continue to offer CommUUnity Night on first Fridays for potluck supper and games, but without nursery coverage. This continues to be one of our most popular events.

Jenny Hastings has provided nursery care since she was hired in December of 2015. We have experienced record numbers in the nursery attendance. Her popularity with parents has resulted in larger numbers of families with small children attending evening events. Gale Callaghan has assisted Jenny as a youth volunteer. We all depend on Gale and honor his commitment.

On March 4th of 2016, I tripped and fell in the middle classroom resulting in a broken shoulder. After surgery and eight weeks of recovery, I am currently returning to work on a limited basis. Terrific volunteers Donna Neff, Sheri Conner, Kate Wiig, Adam Sagert and Roman Noriega organized the Spring Carnival and wrote Sunday School lessons for the weeks I was absent.

YRUU has needed a sustainable plan for the turnover of advisors. This year, Molly Kliment-Jenkins (DRE 2nd UU) and I met with youth and parents to rewrite a policy to guide the group in the future. Two primary advisors, one from each congregation, were recommended by the Transition Team and submitted to the group for approval. The new advisors will work together with each other and with Molly and I over the summer to prepare for the new year in the fall.

Our Religious Education program has purchased a one-year membership that will provide this group and adult sponsors with admission for board game playing from 9:00-12:30 on Sunday mornings only. Ryan Cook gathers the group by the elevator and walks from church at 10:30. At Spielbound they have the traditional check-in followed by a game selected by Ryan and Bethany Cook. Abby Cape and Geoff Chenoweth also provide adult guidance.

We honor the contribution of our two YRUU advisors who are stepping down this year after serving faithfully for a decade. We extend our sincere thanks to Ben Wallace and Shawne Coonfare for their leadership with the youth.

We enjoy increased attendance in both Sunday classes and weekday events.

### Twenty Years Ago — 1995-1996

The Annual Report for 1995-96 begins with Ron Knapp's farewell as he concluded his 20-year tenure as our minister. He noted that ministers come and go but the church goes on forever. He concluded with a short poem by James Russell Lowell which contains the line "New occasions teach new duties."

President Bob Slaughter reported that the church had made considerable progress in pursuit of several goals. He noted that the elevator project was on hold due to some changes in state regulations. The money for this project was held in escrow. He also applauded the hiring of Cheryll Wallace as the Director of Religious Education calling her a "godsend." Jan Wilson, chair of the Religious Education Council, also lauded Cheryll's work since coming on board in November.

Jack Perry chaired the Interim Minister Search Committee which began its task in November of 1995. He was happy to report that on April 23, 1996, Rev. Angeline Theisen had signed a contract to serve as Interim Minister for one year beginning in August.

During the past year the church welcomed 26 new members bringing our total membership to 273.

### **Archives Team**

#### Activities — 2015/2016:

We are approaching two major milestones in our church's long history. In the church year 2018/2019 we will celebrate two key anniversaries: the centennial of the dedication of our church (1918) and the sesquicentennial of the founding of the First Unitarian Church of Omaha (1869).

In preparation for the celebration of our heritage, the Archives Team has been increasing our activities. We have been holding bi-monthly "Archives Parties" usually on the third Thursday of the month in the Common Room. These "parties" are actually thinly disguised work sessions designed to help organize, categorize and otherwise put things in order. One of the primary goals of this project is to compile and publish a comprehensive history of the church.

A number of people have already assisted in sorting documents, photos, sermons and other holdings. Several members have agreed to share their skills in production of this publication. ### **Capital Trust Fund**

The Capital Trust was established in 1981 to provide management of the Church's long-term capital investments and keep them independent of the daily operations of the Church. The Trustees of the Capital Trust (who serve staggered three year terms) during the past year were Evelyn Whitehill (May 2018), Tim Duggan (May 2016) and Steve Hutchinson (May 2017).

Investment income is distributed monthly to the Church for operating expenses. Preservation and growth of the principal is the primary directive and principal cannot be distributed to the Church without a vote of the congregation. The Trust also handles the investments of two small restricted use donations: Music and Women's Alliance. There is some question about whether the Women's Alliance fund is a restricted fund of the Church or whether it belongs to the Church and is segregated by the Board for use at the recommendation of the Women's Alliance. That matter is to be resolved by the Board.

Approximately 69% of the Trust's total assets are invested in two Vanguard equity funds. The balance of the investments are invested in Fidelity and T. Rowe Price current income funds—15% in mortgage funds and 16% in bond funds. The Trust no longer holds any cash.

In the Fiscal Year ended April 30, 2016, the Trust distributed \$13,650.88 of income to the Church (compared to \$13,393.14 last year). Of that total amount, \$12,816.57 was attributable to regular trust income and \$834.69 to restricted use income. During the year, the market value of the investments managed by the Capital Trust Committee decreased from \$493,086.62 (at April 30, 2015) to \$484,435.02 (at April 30, 2016). During the last fiscal year year, the Capital Trust Fund produced a net gain of 1.0% which consisted of a yield of 2.8% that was distributed to the operating budget of the Church partially offset by a loss of market value of the investments of 1.8%. This performance tracked closely with broad stock market indices. For instance the S & P 500 index, a broad measure of domestic stock performance, declined 1% (from 2085 to 2065) during that period.

### **Caring Team**

**Members:** First Unitarian is a caring congregation! However, our Caring Team, which consists of approximately 28 members, does its best to lead this effort. We coordinate most of our activities by email with in-person meetings in the fall and spring.

#### Activities — 2015/2016:

The Caring Team responds to the needs of our congregation by giving support for special needs wherever possible. There are also regular functions we attend to such as greeting cards for holidays, hospitality at memorial services, rides for individuals as needed, and annual activities listed below.

We send out greeting cards and well wishes to the people on the caring list. This is handled by Terri Lynn Brewer. At Christmas we purchase and send poinsettias to everyone on the caring list.

This year we served coffee at memorial service receptions for Barbara Rippey (Sept. 12, 2015), Alex Nather (Sept, 30, 2015), Carol Cronin's husband, John Cronin (Nov. 13, 2015), Mark Loscutoff's father, Jack Loscutoff (Oct. 17, 2015). Special thanks go to Kay Lynn Goldner and Deb Duggan for coordinating memorial services. There are many unsung heroes on our Caring Team and in our church! These are the people who respond to requests for help and do more than might be expected in caring for our church family.

### Sub-Team of Caring: Hope in Action

#### Activities & Projects — 2015/2016:

Hope in Action was launched in August, 2014 as a new sub-team of the Caring Team. The purpose of Hope in Action is to make it easier for First Unitarian Church of Omaha members, friends, regular attendees and their spouses to ask for support. Hope in Action is available when people are dealing with a medical problem, need transportation or help around the house, can use assistance with referrals to social service agencies, or just need someone to talk to about the ups and downs of life. Short-term emergency financial assistance may be available for lodging, food, clothing, medication, transportation and utilities.

Hope in Action uses a team approach, so at least three members of the Hope in Action team must participate in determining the nature of the response to a request for assistance.

Requests for assistance must be made directly by the person needing help. Hope in Action does not respond to any anonymous or third party requests for assistance. A confidential request for assistance from Hope in Action may be made by (1) sending an email to the designated email address, (2) using the Hope in Action link on the church website, or (3) calling the church office and leaving a message in the designated voicemail box.

Hope in Action has developed an Omaha Resource Guide for social service referrals that is provided to folks who contact Hope in Action and people who come to the church door seeking assistance.

Hope in Action provided the following support during the past year:

- Purchased thirty-day unlimited bus pass to help with transportation to a new job (\$55).
- Helped person apply to Together Inc. for rent and utility assistance to prevent eviction and utility shut-off.
- Created signup genius to provide rides to church for member who was no longer on a bus line.
- Assisted member with large medical bills needing help interpreting health insurance claims.

- Counseled member who was victim of financial abuse.
- Contributed \$50 toward purchase of a train ticket for person referred by PFLAG who was fleeing an abusive relationship.

• Provided financial counseling and made an emergency loan of \$266 to church member to pay delinquent debts, with a \$30/month loan repayment schedule.

#### Activities — 2015-2016:

Once again First Unitarian Church has stepped up to take an active role in community outreach through Community Meals. A very committed group of volunteers regularly staff the dining room at First Baptist Church along with other church members who attend individual dates. Volunteers set up and clean up, and pick up the free groceries from Trader Joe's that we distribute to our guests. This year that group has included Kay Lynn Goldner and Louise Jeffrey (who, along with Vickie Hawks Love, are leaders of the weekly crew), Dean Christensen, Linda Hess, Brian and Kim Callaghan, and Terri Lynn Brewer. New to our frequent helpers were Andrea and Martin Hayes. There are numerous volunteers who regularly donate desserts, cook and clean, but they are too numerous to list!

Over the course of the year, in addition to weekly volunteers, and with the help of other First Unitarian volunteers, we served five meals (one more than we normally do). Sign-up sheets, both online and paper, were offered to those interested in participating, beginning three to four weeks before each meal. While we partially fund the meals through Share the Plate donations, many people generously donated the food they prepared. Cooking is done by volunteers who sign up to. The meals this year included: pulled pork sandwiches, enchilada casserole, Little Caesar's pizza, chili, and a fried chicken deli dinner.

Upon each occasion, an enthusiastic crew of First Unitarian volunteers met at First Baptist to finish preparing food, visit with guests, serve and clean up. The meal begins with a blessing, usually given by Reverend Frank, and it is a rewarding time of camaraderie with friends and a chance to be of service to our neighbors and the church community.

Thanks to our generous congregation, we had the funds to add to our services this year with regular monthly meals for YES (Youth Emergency Services). Kim Callaghan is heading up this volunteer crew, preparing meals for 50-75, at home and in our church kitchen. No service is required — the meals are delivered in the early afternoon and have been enthusiastically enjoyed.

#### Activities & Projects — 2015/2016:

Mystic Sojourn CUUPS has had a great first year. As part of a national organization, our goals include educating people about paganism and promoting interfaith dialogue, along with encouraging the greater use of poetry, dancing, and creative rituals in Unitarian Universalism worship. As a group, we embrace the spiritual teachings of earth-centered traditions which celebrate the sacred circle of life and instruct us to live in harmony with the rhythms of nature. Our Mission Statement is to pledge ourselves to explore, respect, and revere the earth-based spiritual path.

We have been holding alternate public and private monthly meetings. Alan created a climate change statement that became OTOC's official statement on climate change. Alan and Elaine testified at the January 22, 2015 OPPD Board meeting in favor of a proposed Demand Management program that would help spread the demand for power during the hottest summer days. Alan and Janet testified at the November 2015 OPPD Board meeting to oppose OPPD's rate restructuring plan. Alan, Janet and Laurie hosted a public event about OPPD's rate restructuring program in December 2015. OPPD's President, Tim Burke, attended along with approximately 100 others.

On March 31, 2015, Laurie joined OTOC in meeting with Governor Ricketts. She discussed climate change and UNL's study of the impact of climate change on Nebraska.

Throughout 2015, Laurie and Elaine met with approximately six state senators to discuss climate change and UNL's study of the impact of climate change on Nebraska.

Laurie chaired several events at Urban Abbey Coffee shop to inform the public on climate change, legislative bills and OPPD issues. Laurie co-chaired the "Prayers for the Planet" event in September 2015. The event highlighted Pope Francis' Encyclical on Climate Change. Approximately 150 people attended. OTOC's Environmental Action Team took the following positions on legislative bills:

#### Activities & Projects — 2015/2016:

The Finance Team has responsibility for advising the Board, the Ministry Team and the Treasurer on the financial functions of the church and assists the senior staff in carrying out specific functions. Walt Jesteadt continued to serve as Treasurer as well as Finance Chair. Work completed under both headings will be summarized here, but finances for the year and a proposed budget for the 2016-2017 year will be presented in a separate report. The Sarah Joslyn Society and Fundraising are also covered in separate reports.

• During the past year, Bill Ross continued to perform many church accounting functions including the payroll. Catharine Dixon continued handling most of the data entry and took over some accounting functions. Clyde Kramer handled disbursements. Walt Jesteadt handled contribution statements, monthly reports to the Board and automatic withdrawals through Vanco.

• Contribution Statements were mailed in July, October, January and April. The January mailing for tax purposes is required by law. The April mailing provided information on the status of pledges before the end of the current church year as well as information on new pledges. We continued to email contribution statements to 75 households that gave us permission to do so.

• The Preserve Our Building Fund campaign was again held in January/February, with the help of Jamie Alexander and Louise Jeffrey. The fund total increased from \$51,924 in February 2015 to \$58,758 in February 2016.

• The members who pay their pledges by monthly automatic deposits handled by Vanco increased to 38 during the year. All Vanco contributors were contacted during the stewardship campaign to ensure that Vanco transfers in May would be consistent with new pledges. Our Excel summary of Vanco participants was updated.

• A \$165,000 bequest from Katherine McClure, combined with other bequests and successful management of our operating budget has given us cash reserves of approximately \$500,000. A joint meeting of the Finance Team and the Capital Trustees in October resulted in a recommendation to the Board to invest \$200,000 in the UUA Common Endowment Fund. This will be completed by the time of the annual meeting.

• Clyde Kramer continued coming to the church office once a week to handle disbursements.

### Foyer Improvement Project — 2015/2016

The foyer of the church was renovated to create a welcoming first impression for visitors and members. Dean Christensen pushed to have the project completed with an initial donation of \$20,000. The Board of Trustees approved funding up to an additional \$12,000. Additional donations were received to cover construction services or to purchase specific items. Member input was solicited at meetings in April and July of 2015. Design options were shared and a final design selected.

Demolition started September 14, 2015 with the removal of existing cabinetry and the repairing and repainting of the walls. Custom wainscoting, built-in coat racks, storage areas, and a nametag display cabinet were designed and installed. All wood molding and trim were made to match existing trim found in the church. New walk-off type carpet was installed. The entry doors were repaired and painted and period door hardware installed. Antique furniture and period reproduction furniture was purchased. The existing Sack-Back arm chairs in the sanctuary were sent out for repair and refinishing. The chancel table was repaired and the top refinished. Protective glass was purchased and added to all tables and cabinet tops.

The result is a beautiful new foyer which now enhances our lovely sanctuary.

Church note: Our sincere thanks to Marie Sedlacek who spent countless hours designing and managing the project and to the following craftsmen: Tim Earl, custom carpentry; Traco, Inc., painting; Don's Refinishing Service, furniture repair and refinishing; Nebraska/Iowa Door Services, door hardware.

Donations will be formally recognized as part of the project.

### **FUNdraising Team**

#### Activities & Projects — 2015-2016:

This year's operating budget assumed \$17,000 from fundraising, holding last year's level. We successfully reached that goal, contributing \$17,467 to the budget as of the end of February.

Chili Cook-Off profit yielded about \$500 and sale of gift cards added some income, but the majority came from our big annual event, the Halloween Heart & Hand Auction Party. Held Friday October 23, 2015, people attended, many in costume, to bid on 162 donated items, concerts, dinners, services and fun activities. The events filled the calendar nearly every weekend from November through May. Billing post-auction again worked quite well. Besides generous donors and buyers, it took over 50 volunteers to pull it off, with special thanks to Kabin Thomas, our emcee and auctioneer, the Fellowship Team, and Walt Jesteadt and Carolyn McNamara for heading set-up/logistics. Auction related tasks now spread year-round for us, including billings, monitoring, post-auction open seat sales, etc.

We discontinued scrip sales this year because of effort relative to profit and ethical concerns about particular merchants. We end the year with a new venture: preparing for the church to participate for the first time in Omaha Gives! on May 25, a community wide fundraiser for non-profits.

#### Activities — 2015/2016:

The Lecture Committee sponsors two lectures per year, one in the spring and one in the fall. To date, 22 lectures have been sponsored.

On September 24, 2015, a lecture titled "Your Voting Rights, 50 Years after Selma" was given by Dale Ho, Director of the ACLU's Voting Rights Project, which is dedicated to defending the freedom of all Americans to vote. He is an adjunct professor of law at Brooklyn Law School and NYU School of Law. Prior to joining the ACLU, he was Assistant Counsel at the NAACP Legal Defense Fund. He is a graduate of Princeton and the Yale Law School.

On May 11, 2016, Dr. Naomi Oreskes is scheduled to present a lecture titled "The American Denial of Climate Warning." Dr. Oreskes is Professor of the History of Science and Affiliated Professor of Earth and Planetary Sciences at Harvard University. Previously she was an administrator and faculty member at The University of California, San Diego. She is the author of *Merchants of Doubt: How a Handful of Scientists Obscured the Truth on Issues from Tobacco Smoke to Global Warming* and *The Collapse of Western Civilization: A View from the Future*.

The Committee funds its activities through contributions by Dick Holland.

The Hospitality Teams concept began in 2014 as a new way to approach the Sunday morning tasks we are all familiar with. The goal is to provide opportunities for each congregation member to help serve the congregation and support the church services; to belong to a team that works together on a regular basis and take a turn in its leadership; to learn the work that is required to bring our services together, share the knowledge with other team members, and help improve the process; and to become an integral part of welcoming all newcomers to our church.

It takes about 108 volunteers (nine teams of twelve people each) to make Hospitality Teams work. The teams are purposely large so that team members who may have to be gone for work or are traveling on the Sunday that their team is scheduled, can be gone without disrupting the smooth flow of the team's work. Currently, the average team has eight members but more are needed. Each team serves six times per year — once every two months. Four teams serve one Sunday during each of the odd numbered months (September, November, etc.) and four other teams serve one Sunday during each of the even numbered months (October, December, etc.). A fifth team serves each time that there is a fifth Sunday in a month (generally 4 times per year). Team Coordinator Kim Callaghan is the conduit between the individuals and teams that create our Sunday services and the Hospitality Teams that serve on any given Sunday.

Serving on a Hospitality Team takes about one hour and it only happens six times per year. Some people come in early to set up and some people stay a bit late for clean-up. Because everyone works together, nobody has to spend lots of extra time. Tasks include greeting congregants and visitors when they enter the church; taking up the offering; preparing coffee and refreshments; answering questions and giving directions; tidying up after each service; visiting with newcomers and helping them feel at home. All of the tasks are documented and introductory training is offered. Team members rotate through the tasks so everyone can do every job.

Hospitality Team Leaders mainly do team coordination. Team Leaders receive information about what is planned for the services from the Hospitality Team Coordinator and share it with their team members. The Team Leader checks to see who will be able to attend on Sunday and schedules who will perform each of the various roles. The tasks are rotated until everyone has a chance to become familiar with each one.

It has been rewarding and fun and we hope you will volunteer for a Hospitality Team and join us!

The volunteers also fold, seal and prepare the monthly *Flame* for mailing. We are very grateful for such a devoted volunteer staff.

The church's information technology applications are growing. The church now has seven PCs in use and these will be updated to Windows 10 this summer. Two Apple computers are also in use for music and streaming applications. We also maintain an Ethernet network and three WiFi networks.

In March, we welcomed Cassi Moucka as the new caretaker of the Wayside Pulpit.

In April, the office was thrilled to welcome a new photocopier which is smaller yet faster and more efficient.

This year, Catharine redesigned the look of both *The Flame* and the enews. We now have almost 600 people who receive the weekly enews and the emailed monthly newsletter.

The 2016-17 Stewardship Drive kicked off this year in mid-January with new committee members and a newly proposed budget. On February 9<sup>th</sup> the Board approved the new budget which asked for a \$10,000.00 increase from Stewardship. Amid the concerns we felt over the required increase, plans were implemented and the team got to work.

The month long drive really began with the "Pillar Party," hosted by John and Kay Lynn Goldner on February 28 at their condo party room. Approximately 25 attendees met to visit, enjoy conversation along with appetizers and cocktails provided by the Stewardship Committee members. After a brief message from both John Goldner and Rev. Frank, over 62% of this year's Stewardship goal was pledged by attendees.

The next steps included the preparation and mailing of the pledge packets and the weekly reminders by inspirational speakers including Board President Jack Round, Ryan Cook, Harriet Major, and Carol Cronin.

The month was rounded out by the all-church Fabulous Fiesta planned by Mary Kay and Peg. The festive occasion featured a taco bar and we celebrated members and friends with meaningful photos of service and involvement on Judith Wright's beautiful centerpieces. The drive was completed through calls to members and friends who had not yet pledged. Callers included Ron and Diane Withem, Louise Jeffrey, Walt Jesteadt, David Richardson, Jaime Alexander, Maria Wallace, and Kay Lynn Goldner. To date, we are happy to report we reached our pledge goal of \$260,000

### Sunday Services Live Video Streaming and Archives

#### Activities — 2015/2016:

Initial research into and evaluation of live video streaming of services began in earnest January 2015. The effort was based upon the concept of using iPod cameras and an iPad video production solution which was a cost-effective method to film and upload video directly to YouTube for distribution. We spent several months learning the software and testing various camera placements, lighting efforts, sound board integration, and Internet wifi bandwidth requirements. And we tested the early service versus the late service before identifying and implementing a solution that would work for the Early Morning Risers to avoid music license violations when performing copyrighted material during services.

After a brief interruption to the effort in the summer of 2015, we worked through the majority of the issues in the fall. We increased the church Internet bandwidth, configured a private video wifi network to limit bandwidth constraints from other traffic on the network, refined the camera placement and audio balance, and added title slides throughout the video based on the Order of Worship each week.

In October 2015, we started publicly posting live streams of the services each week to the firstuuomaha.org website and archiving the broadcasts. We still struggled with periodic wifi interference causing hiccups in the video stream. However, each week the video tended to improve as we continued to make refinements. During the first quarter of 2016, we averaged about 20 views of the online service, either live or archived, each week. The livestream quality has remained consistently good.

To make it consistently great, we are currently transitioning to a new production system and targeting the end of May for it to be fully implemented. Using traditional video cameras with significant optical zoom directly connected to a laptop running new video production software and a hard-wired Internet connection in the organ loft, we hope to bypass the wifi issues we've experienced and double or possibly triple the resolution of the live video we are currently posting to the website.

We are now recruiting volunteers to take turns filming and producing the video during services. It only requires one individual each week. But to ensure sustainability of the livestream video broadcast, the church needs more than one individual available to implement the live video from week to week. Every step of the production process is documented, so there aren't any real technical skills required. Everyone can help make the live video streaming an ongoing success.

#### **Group Summary:**

Young Religious Unitarian Universalists (YRUU) is for youth in grades 7-12 and is a joint youth group between First and Second Unitarian Churches of Omaha. They meet on Wednesday nights at First Unitarian Church. The YRUU year runs in conjunction with the school year (September – May).

The goals of YRUU are to:

- Grow life-long Unitarian Universalists
- Provide worship, celebration and rites of passage for UU youth
- Learn about the traditions and heritage of Unitarian Universalism
- Develop personal growth, relationship building & leadership skills for youth
- Help youth to develop a social conscience and learn to be agents of change, as a group and individually, in the world
- Develop continuity and foster communication between age levels of youth within the program
- Foster tolerance, understanding and acceptance of diversity.

**Youth Adult Committee:** One focus of YRUU is a youth-leading structure within the group. The Youth Adult Committee (YAC) is comprised of all youth interested in taking leadership roles, youth advisors, and interested parents. The YAC utilizes the feedback gained from the full representation of youth and parents to plan and organize programming with the structure of "The 6 Pillars of Balanced Youth Ministry" (from the UUA Office of Youth and Young Adult Ministries) — Building Community, Social Action, Worship, Learning, Leadership, Congregational Involvement. The YAC meets between one and three times monthly in order to ensure effective leadership for the YRUU, to plan weekly programming, events, and activities, and to formalize the structure of youth leadership within YRUU. In the past the YAC has had officers but this year the youth chose to forego officer positions and instead focus on all members of the group working together to plan and execute our programming and events.

**2015 – 2016 YRUU Activity Summary:** We learned and had some amazing discussions this year including learning and discussing important topics. A great focus of the year was building inclusive groups and communities. Through the generous support of the congregations and many fund-raising efforts, YRUU was able to participate in programming with Inclusive Communities.

Inclusive Communities Program Activities included:

- A day-long workshop on "Creating Inclusive Communities" for all youth, parents, and church and youth leaders
  - A year-long internship for two youth (Noah Giron of 1<sup>st</sup> Unitarian and Sabrina Short of 2<sup>nd</sup> Unitarian),
  - A four-day intensive residential program called IncluCity attended by two advisors and 12 high school youth.

Other YRUU activities included:

- Youth-led discussions on science, political correctness, and discrimination topics
- Multiple music worships with youth-selected songs on various themes and a discussion about why the music they selected was meaningful to them
- Trust-building and leadership exercises led by parent Justin Short
- Former advisor Mary Anne Chisholm facilitating an exercise to decorate a metal sculpture, which was featured as a part of the Transgender Day Of Remembrance (TDOR) ceremony on Friday November 20, 2015. The sculpture was auctioned at the event and all proceeds were donated by the YRUU to the Open Arms TransYouth Group (www.openarmsomaha.com)
- A letter-writing campaign for the National "It Gets Better" Project (www.itgetsbetter.org) supporting LGBT Youth
- Viewing of Documentaries from the Teaching Tolerance curriculum (http://www.tolerance.org) on bullying as well as how youth efforts played an important role in the march on Selma and the Civil Rights movement
- A panel discussion on sexual orientation and gender identity with guest panelists from our First and Second U as well as the larger Omaha metro area
- Participation in the "Dollars for Dodge Ball Fundraiser" supporting the Family Housing Advisory Services program to help youth aging out of foster care
- Attendance by three youth and an advisor at a Youth Conference in Rochester, Minnesota focused on leadership and community building

This year's YRUU activities ended with a potluck at First Unitarian (a celebration and honoring of one another and time spent together over the year), as well as a youth service for the entire congregation, which is youth-led and focused (on Mother's Day weekend).

## Other Programs typically facilitated by YRUU (the facilitation of these programs may change as the Transition Team looks at the future of where these programs fit inside of the RE structure and Omaha UU community):

- <u>Coming of Age</u>: Unitarian Universalist teenagers 9<sup>th</sup> Grade or older usually join their congregations with a special "Coming of Age" ceremony. This ceremony is often preceded by a year-long curriculum helping them to learn more about Unitarian Universalism and articulate their own beliefs. The Coming of Age ceremony usually features the youth reading their statements of personal belief (credo statements) to the congregation (typically incorporated into the Youth Service at the end of the year in May or June). This year, due to conflicting school events, no youth chose to participate.
- <u>Our Whole Lives (OWL)</u>: The OWL program helps participants make informed and responsible decisions about their sexual health and behavior. It equips participants with accurate, age-appropriate information in six subject areas: human development, relationships, personal skills, sexual behavior, sexual health, and society and culture. Grounded in a holistic view of sexuality, OWL not only provides facts about anatomy and human development, but also helps participants clarify their values, build interpersonal skills, and understand the spiritual, emotional, and social aspects of sexuality. Our current OWL program is a 26 week/lesson cycle, and the current curriculum, as well as advisor training, is tailored for youth 7<sup>th</sup> grade and older. Parent preview and consent is required prior to participation. (We did not have a session this year as typically we offer this curriculum every other year.)
- <u>Bridging:</u> The developing Bridging Program is a time for introspection and sharing for graduating high school seniors with peers in the YRUU community and adult mentors/ advisors. It gives the youth a chance to reflect on their spiritual path in a meaningful way, with respect to this significant time of transition from being youth to young adults, as well as what that means for the next journey in life.

**Strategic Efforts:** As the spring semester started, youth and adults came together for a planning session facilitated by the DREs from First and Second U to look at what policies were in place for our continued partnership and the sustainable planning for future adult advisor and coordinator roles. A Transition Team was formed, representing the commitment of both congregations toward recognition and support of a sustainable and well-supported YRUU as an important ministry of the churches and a place for youth to learn, grow and be in community together. The group agreed that this support should include financial and physical support, a well-planned out process of advisor recruitment, vetting and selection, as well as processes such as advisor training, ongoing mentoring and support, and a continuous succession plan. We know that the future of the thriving YRUU program and the achievement of its goals to provide a safe, transparent, inclusive, inviting, and strong environment for our youth depends on everyone working together. The critical role that active youth and parent involvement and voices plays along with leadership and support from the DREs, Ministers, Board Members, and volunteers will ensure that we continue to create a strong, more sustained future for YRUU.

#### Comments on the 2014/2015 Treasurer's Report and 2015/2016 Proposed Budget

#### **Recent History**

This year marked our fifth in a row with an end-of-year surplus, after several years in a row with large deficits. Our budgets have been accurate in assumptions regarding income, but have tended to over-estimate our true expenses and that was true again this year. Given our many functions and programs managed by a mix of full-time staff, part-time staff and volunteers, it is not surprising that we over estimate our need for financial support in some areas. We try to anticipate needs in all areas and give leaders budgets that are adequate to meet their needs. End-of-year surpluses are transferred to our reserve account. When necessary, we have proposed that a portion of the end-of-year surplus be carried over to be used as income for the next year. This has allowed us to have a lower goal for the stewardship campaign than we might otherwise have while assuring everyone that we will be able to meet our needs throughout the year.

#### Results for 2015-16

On June 10, 2015, the official end of last year's stewardship campaign, which began as usual on March 1<sup>st</sup>, we had total pledges of \$250,453. We budgeted \$245,000 in pledge contributions for the year that ended on April 30, 2016 because we were at about that level at the time of the annual meeting. We assumed \$5,500 in carryover from the previous year to make the budget work. Total pledge contributions were \$248,426 and income was above budget in several other categories. The net result was that we did not actually need the \$5,500 in carryover and were \$586 over budget for income without it. Expenses were \$9,171 below budget. Several categories were above budget, but we had large savings in the Building and Grounds category because of lower utility costs and because we did not spend as much from our maintenance fund, which covers the cost of miscellaneous repairs during the year. We were also under budget in Program Expenses, a category that includes religious services, religious education, and some of our outreach programs. The net result is that we finished the year with a surplus of \$9,757, without use of any surplus funds from the prior year.

#### Stewardship Campaign

The goal for the stewardship campaign this spring was \$260,000, an increase of \$15,000 or 6% over last year. As of May 10, 2016, we had 139 pledges for the new church year totaling \$260,281. The number of pledges is down slightly from last year, but the total is a new record. There is a separate report from the Stewardship team.

#### **Proposed Budget**

The proposed budget assumes pledge contributions of \$260,000 for the coming year and use of \$2,875 from the 2015-2016 surplus as additional income to balance the budget. If our expenses continue to be somewhat lower than projected, we will not need those funds. The budget assumes that the Membership Coordinator will be supported from a non-budget growth account, but if expenses are lower than expected, we may be able to absorb that cost as well. Our cash reserves have increased this year due to a large bequest and we have sufficient non-budget funds to meet any need short of a major building expansion.


